

## **Background**

Stella Creasy MP and Conor McGinn MP tabled amendments to the *Northern Ireland (Executive Formation) Bill*. These amendments would allow for the decriminalisation of abortion in Northern Ireland, and provision for same sex marriage to come into effect on 22nd October.

Until now, in Northern Ireland abortion was only legal in circumstances where the woman's life is in danger or the pregnancy poses a serious, permanent or long-term risk to her health and wellbeing.

In 2016, the UN Committee on the Elimination of Discrimination Against Women conducted an inquiry on the subject of access to abortion in Northern Ireland. It concluded that the rights of women in Northern Ireland were being violated by restrictions on access to abortion, and argued that devolution of power over criminal law to the Northern Ireland Assembly did not remove the responsibility of the UK Government for this matter.
